Terms & Conditions:

- a. All individual C-Channel should have ABS/NKK/BV stamp. Heat no or Batch no & Grade shall be stenciled/die punched by the relevant Classification Society.
 - b. Mill Test certificate is also to be supplied along with shipping documents.
 - c. All the materials are to be tested by ABS/NKK/BV classification Society & test certificate endorsed by the classification society showing Heat no & Batch no is to be submitted along with shipping documents.
 - d. Manufacturer certificate regarding the chemical composition & mechanical properties is to be provided along with shipping documents.
 - e. Each C-Channel is to be Shop primed before shipment.
 - f. Plus/Minus 10 (ten) percent tolerance will be allowed on total quantity, length & breadth. Negative allowance will no be permitted on thickness of the plates.
 - g. Weight will be counted as per theoretical weight basis. During weight measurement, the positive fraction of the thickness is not countable.
 - h. An article wise compliance statement is to be submitted along with the offer.
2. Please send your offer on CFR Chittagong basis by close envelop.
 3. Tender Opening Date & Time: 11/09/2019 (1130 Hours)
 4. Insurance will be covered by this organization if offer CFR basis.
 5. Payment should be made through L/C. 80% against shipping documents and rest 20% after satisfactory receiving the material.
 6. Shipment: 45 days from the opening date of L/C or Purchase Order.
 7. Offer Validity: 90 days from Tender Opening date.
 8. **1%** (one) Bid Bond of the total quoted CFR value must be submit with offer Bid Bond may be Bank Draft/ Pay Order/ Bank Guarantee in favour of Khulna Shipyard Ltd, Khulna.
 9. 10% Performance guarantee is to be submitted before Purchase Order.
